PHILIPP transport anchors - no approval required

Dear Sir or Madam.

The DIBt in Germany has confirmed the following on the subject approval for transport anchors:

"Anchors that are used exclusively for the transport (for lifting) of prefabricated (reinforced) concrete parts (transport anchors) are not construction products within the meaning of public building law. For transport anchors a proof of usability in the form of a technical approval is therefore not required." (Translation from letter dated on 20.11.17)

The Employer's Liability Insurance Association of Construction Industry is responsible for occupational safety during the transport of precast concrete elements (see German DGUV regulation 101-001). For the assessment of the load limit of transport anchors EN 13155 in combination with the VDI/BV-BS 6205 guideline or CEN/TR 15728 shall be taken. However, the responsibility for the design of the anchors is on the planner, for installation and handling on the producer of the precast elements. All permissible loads of PHILIPP transport anchors given in the corresponding Installation and Application Instructions result from tests which were done and evaluated in the presence of a certified expert acc. to the VDI/BV-BS 6205 guideline, para. 9.3.1.1.

PHILIPP transport anchors comply with either the latest requirements and safety standards of the EN 13155 or the VDI/BV-BS 6205 guideline "Lifting inserts and lifting systems for precast concrete elements" resp. the German DGUV regulation 101-001 "Transport anchors and -systems for precast concrete units". Among others PHILIPP has been actively involved in the creation of these guiding documentations.

An internal incoming goods and production control acc. to EN ISO 9001 is regularly done and certified by TÜV Süd.
